## **Announcement of intention to apply for the organization and leadership of the Sectoral Council for Renewable Energy Competencies**

We hereby inform you that in accordance with section 4.2 of the Competition Rules for the organization and leadership of sectoral councils for competencies, pursuant to Article 4e(6) and (7) of the Act on the Establishment of the Polish Agency for Enterprise Development (Journal of Laws 2024, item 419), Green Energy PL 9 Sp. z o.o. (Rondo Daszyńskiego 2b, 00-843 Warsaw) intends to submit an application to establish a sectoral council for competencies in the Renewable Energy sector (OZE). In connection with this, we invite industry organizations and all interested entities to express their interest in participating in the work of the sectoral council. ### **Planned objectives of the Council's activities:**

1. Gathering knowledge from businesses about the qualification and professional needs present in the labor market in the Renewable Energy sector.
2. Disseminating information about the qualification and professional needs of the sector.
3. Initiating cooperation between businesses and universities, as well as educational institutions, to integrate education with employers.
4. Formulating recommendations in the field of Renewable Energy.

### **According to the Guidelines for the organization and operation of sectoral councils:**

The aim of the sectoral council system is to involve employers as widely as possible in identifying and forecasting competency needs in the labor market and to influence providers of educational and development services to create a high-quality educational and development offer, adequate to the labor market needs.

Sectoral councils at the sector (industry) level monitor the demand for competencies, taking into account its specifics and the expected changes in its functioning. The monitoring is primarily based on the expert knowledge of the members of the Sectoral Competence Council (SRK) as well as their own and external research.

The aim of the sectoral council system is to reduce the competency mismatch in the labor market by providing information about competency gaps in sectors, accompanied by a range of other activities, such as:

1. Gathering knowledge from businesses about the qualifications and competencies sought in a given sector of the economy.
2. Preparing recommendations for adjusting the workforce to the current needs of businesses in a given sector of the economy.
3. Identifying proposals for organizational solutions/legislative changes in the area of education/labor market to best meet the required qualifications and competencies in the sector.
4. Initiating cooperation between businesses and universities, as well as entities mentioned in Article 2 of the Act of 14 December 2016 – Education Law.
5. Cooperation in the area of educational agreements aimed at integrating education and employers.
6. Identifying the need for creating a Sectoral Qualifications Framework and qualifications.
  
7. Disseminating information about the identified needs

Joining the Sectoral Council for Renewable Energy Competencies offers the opportunity to influence the future of the sector and gain access to market analysis and research, which will help forecast trends. We cordially invite you to contact:
